Special arrangements are not guaranteed unless they are agreed upon in writing prior to the event date. Any special requests must be submitted no later than two weeks prior to the event date. SHS will not provide insurance to cover related operations.

Bands must submit both a Sequoia Humane Society AND City of Eureka waiver of liability form with their vendor application.

All applicable fees, insurance and registration forms must be received by August 1st, 2022.

VENDOR AGREEMENT Woofstock 2022

Sequoia Humane Society Waiver of Liability Form

_____ (Referred to hereafter as “BAND / BAND REPRESENTATIVE”) agrees to defend, pay on behalf of and hold harmless the Sequoia Humane Society, their directors, officers, agents and employees, from all claims of whatsoever nature or kind, including those brought by employees, volunteers, agents or subcontractors of said BAND/ BAND REPRESENTATIVE, relating to the event, to be held Saturday August 13th, 2022, in Eureka, California, in which said BAND REPRESENTATIVE will be participating.

BAND / BAND REPRESENTATIVE agrees to defend and pay all costs in defending these claims, including attorney fees. Further, BAND / BAND REPRESENTATIVE agrees to maintain public liability and property damage insurance to cover the obligations set forth above. If BAND / BAND REPRESENTATIVE does not have insurance coverage BAND / BAND REPRESENTATIVE assumes personal responsibility for any damage or injury sustained while participating in the above activity.

If insured, BAND / BAND REPRESENTATIVE shall furnish a certificate of insurance to the Sequoia Humane Society showing that a qualified insurance carrier provides for the above obligations and requirements, and showing the City of Eureka and the Sequoia Humane Society as additional insured on such insurance.
